### **ORDER:**

In the Government Order first read above, the 'Best Practices Award' was instituted to reward those who have achieved excellent results in good governance and successfully implemented strategies, new initiatives and best practices. The award carries a cash reward of Rs.2.00 lakhs each for three chosen nominations.

2. Nominations for the Best Practices Award are received under three categories, viz., (i) Government employees – individual; (ii) Government employees – as a group; and (iii) Organisation / Institution / Office. For the year 2015, initially 19 nominations were received and the respective nominees gave presentation on their schemes before the Screening Committee meeting held on 29.07.2015 under the chairmanship of Principal Secretary to Government, Finance Department. Out of the 19 nominations received, the Screening Committee has recommended eight nominations after detailed discussions. The 8 nominations recommended by the Screening Committee were placed before the Selection Committee in its meeting held on 4.8.2015 under the Chairmanship of Chief Secretary to Government. The Selection Committee scrutinised the nominations for consideration for the "Best Practices Award" under the categories of Individual and Organisation. The Committee after detailed deliberations unanimously decided to recommend five nominations for choosing three awardees for the Best Practices Award – 2015.

- 3. Based on the recommendations of the Selection Committee and after careful examination of the nominations, Government have decided that the 'Best Practices Award-2015' be given to the following three initiatives:
  - i. Amma Unavagams Canteens in Chennai City
  - ii. Common Service Centres
  - iii. Renovation of Arulmigu Parthasarathy Temple, Triplicane

The details of respective awardees who shall receive the reward amount of Rs.2,00,000/- each are as follows:

The award certificate together with a cheque for an amount of Rs.2,00,000/- (Rupees two lakhs only) each shall be presented by the Hon'ble Chief Minister during the Independence Day – 2015 celebrations.
