ORDER:

The Government of Tamil Nadu is pleased to institute the award of "Anna Medal for gallantry" to be conversed on the civilians in Tamil Nadu and hereby makes the following rules governing them:

- 1. These rules shall be known as the "Rules for the award of anna Medal for gallantry" and shall be applicable to the civilians in Tamil Nadu.
- 2. The award shall be in the form or a Medal and named as the "anna Medal for gallantry".
- 3. The medal will be circular in shape made of silver with gold coating.(having 3/3" diametre). It will have the words inscribed "தமிழக முதல்வர் விருது 1980" (வழங்கும் இன்னட் கூறிப்பிட வேல்கும்) above and the description "சிறப்பிடுதக்கும்" below in Tamil. On the reverse side, it will have the inscription of the words "தமிழ் நாகு அந்து" above and the state Motto "வரய்மையே வெல்வும்" below with the temple motif in the centre. The cost of the medal shall be %.1,000/- (P. pees One thousand Coly).
- 4. In addition to the medal, a cash certificate for ks.1,000/- (Rupees One thousand Only) will also be given.
- 5. The names of those to whom this medal may be awarded shall be published in the Tamil Nadu Government Gazette and a Rejister of such names shall be maintained by the Government of Tamil Nadu in the Public Department.
- 6. The number of medals awarded in a year shall be three on an average.
- 7. The medals shall be awarded to any civilian irrespective of age for conspicious gallantry in saving life, property etc.
 - 8. As the medal will carry the Chief Minister's name, the nominations for its award should be done in all seriousness and the standard of cases reported shall be high.

- The recommendations of the Collectors for the awards shall be placed before the Selection Committee, orders regarding the constitution of the Committee will be issued separately. The recommendation of the committee should reach the Government in the Public department not later than 15th July/15th December every year.
- 10. The medal will be presented by the Chief Minister of Tamil Nadu or the Republic Day or Independence Day.
- The expenditure shall be debited to "268A .Misc. -General Services - AE. Other Expenditure I.Non-Plan-B3 . Galdantry Award for Civilians ... (New Sub head to be opened).
