- 2. During the State Level Committee meeting held on 08.08.2019 under the Chairpersonship of Hon'ble Minister (Social Welfare and Nutritious Meal Programme) for selection under the category of Independence Day Award, it was decided to form District Level Committee to select the nominees for various Awards.
- 3. In the letter read above, the Commissioner of Social Welfare has sent proposal stating that the proposals are sought from districts for selecting eligible persons under various categories in different occasions. In this connection, advertisement is given for each award separately in each district through newspaper. The State Level Selection Committee already formed by the Government has to select the nominees. To obtain

relevant proposals and proper selection of individuals / institutions in time from the districts, it is necessary to form District Level Selection Committee. Therefore the Commissioner of Social Welfare has suggested to form a District Level Selection Committees at each District to select the best nominees for each award. The Commissioner of Social Welfare has sent the details of the District Level Selection Committees for Avvaiyar Award, Third Gender Award and Independence day Award and timelines for advertisement, to receive proposals, scrutiny and forwarding to Commissioner of Social Welfare.
